



Sir,

I am directed to state that on the basis of the recommendations of the Expert Committee of the Southern Regional Committee of the All India Council for Technical Education (AICTE), the AICTE has accorded approval to the Sri Ram Polytechnic, Perumalpattu, Thiruvallur, Tamil Nadu, for conduct of the following 3-year full time diploma courses with annual intakes indicated against each during the academic year 1993-94 only.

Mechanical Engineering	60 (Sixty)
Electronics & Communication Engineering	60 (Sixty)
Electrical & Electronics Engineering (In lieu of Civil Engineering course)	60 (Sixty)

This approval is given subject to fulfilment of the following conditions:-

- 1) Faculty strength in all branches should be improved by recruiting qualified persons in accordance with the procedure qualifications and experience prescribed by AICTE before the academic session 1993-94 begins.
- 2) Library books and journals should be provided as per AICTE norms and a common library with sufficient reading room/reference facilities should be provided.
- 3) Additional faculty should be recruited and equipment required for the new course in Electrical & Electronics Engineering should be procured within one year.
- 4) The Management of the Polytechnic including the Governing Council should be constituted as per the guidelines of the AICTE.
- 5) All admissions should be made as per the norms and guidelines of the AICTE.

- 5) The tuition and other fees should be charged as prescribed by the State Government within the overall criteria prescribed by the AICTE from time to time. No capitation fees should be charged from the students/ guardians of the students in any form.
- 7) The accounts of the Institute should be audited by a Chartered Accountant and should be open for inspection by the AICTE or anybody authorised by it.
- 8) The teaching and other staff should be recruited according to the procedure, guidelines and experience prescribed by the AICTE.
- 9) No new course should be started without the prior approval of the AICTE.
- 10) The intake in any of the approved courses should not be altered under any circumstances without the prior concurrence of the AICTE.

This approval is also subject to full compliance with the provisions of the SCHEME as prescribed by the Supreme Court of India in its Judgment dated 4-2-1993 on Writ Petition (C) No. 607 of 1992.

The Management should strictly follow any further conditions as may be laid down by the AICTE from time to time.

In the event of non-compliance by the Trust or the Polytechnic with the above conditions of the AICTE, the AICTE will be free to take measures for withdrawal of its approval without consideration of any related issues and that all the consequent liabilities would be that of the Trust and/or the Polytechnic.

An Expert Committee of the AICTE will visit the Polytechnic by the end of the academic year 1993-94 to review the progress made in fulfilling the conditions laid down by the AICTE and recommend continuation of the AICTE approval or otherwise.



I am directed to state that on consideration of the recommendations of the Task Force for the State of Tamilnadu which assessed the proposal of the above Institute on 8th & 9th November, 1993, the All India Council for Technical Education has accorded approval to Sri Ram Polytechnic, Perumalpattu, Tiruvallur Taluk, Chengai, M.G.R. Distt. - 602 024 to conduct the following full time 3 years Diploma Course, with the intake shown against each during the academic session 1994-95 subject to the conditions mentioned below.

Existing Courses

1. Mechanical Engineering	60 (sixty)
2. Electrical & Electronics Engineering	60 (sixty)
3. Electronics & Communication Engineering	60 (sixty)

New Course

Leather Technology 30 (thirty)

Conditions to be fulfilled by the Management/Trust:

- (1) The infrastructural and other facilities building for teaching and administrative areas, labs, workshops, library, student amenities, equipment etc. as per AICTE norms shall be provided within six months from the date of issue of the approval.

- (2) The teaching faculty shall be recruited according to the structure, procedure, qualifications and experience etc.; prescribed by the AICTE.
The posts which are not according to the structure of Faculty prescribed by the AICTE, (e.g. those of associate/Asst. Lecturers, etc.) shall be abolished.
 - (3) AICTE scales of pay shall be implemented to the faculty.
 - (4) The admission shall be made as per the guidelines of the AICTE and as adopted by Govt. of Tamilnadu.
 - (5) The tuition and other fees shall be as decided by the State Govt. within the overall criteria prescribed by the AICTE. No capitation fee shall be charged from the students/guardians in any form.
 - (6) A Hostel building and staff quarters as per the minimum requirements as prescribed in the Norms of the AICTE shall be provided by June 1975.
 - (7) The Institute / State Government shall neither close any approved course nor start any new course nor alter any approved intake without the prior approval of the AICTE.
 - (8) Admissions to the approved courses shall be made only after adequate infrastructure and other facilities are provided as per AICTE Norms.
 - (9) The Recurring Expenditure per student/year shall be brought up at par with the Norms of the AICTE.
 - (10) A registered Undertaking by the trust/society of the Institution shall be submitted to the AICTE, Delhi within one month of the issue of this letter confirming the willingness of the Institute to fulfil the conditions laid down by the AICTE from time to time.
 - (11) The Managing body/the Governing Council of the Institute shall be constituted as per guidelines of the AICTE.
 - (12) To meet the financial obligations of recurring and non-recurring expenditure as prescribed by AICTE, adequate Funds shall be maintained.
 - (13) The administrative, academic, and financial records and accounts of the Institution shall be maintained as per the guidelines of the AICTE. The accounts of the Institute shall be audited by a Chartered Accountant and be open to special audit and inspection by the AICTE or anybody authorised by it.


- (13) The Institution shall furnish requisite returns and reports as desired by the AICTE in order to ensure proper maintenance of the administrative and academic standards.
- (14) The informations furnished in respect of the proposal shall be factual and correct. In the event of any information found to be false, misleading or suppressed, the approval accorded may be withdrawn by the AICTE.
- (15) An Expert Committee of the Regional Committee of the AICTE will visit the Institute in August, 1994 in order to assess the fulfillment of above conditions and to recommend the continuation of AICTE approval or otherwise.
- (16) The institute shall submit compliance report relating to fulfillment of specific and general conditions to the AICTE within six months from the date of approval of the letter.
- (17) The institution shall constitute a Planning and Monitoring Board (PMB) as prescribed by the AICTE for continuous monitoring of norms & evaluation of standards.

This approval is also subject to full compliance with the SC/ST EME as prescribed by the Supreme Court of India in its judgment dated 4-2-1993 on Writ Petition (C) No. 647 of 1992, and the related guidelines/criteria as may be issued by the AICTE.

In the event of non-compliance by the Government/Institute with the above conditions, guidelines, Norms and Standards prescribed by the AICTE from time to time, the AICTE will be free to take measures for withdrawal of its approval without consideration of any related issues and that all liabilities due to withdrawal of approval would be that of the Trust/Institute.

It is requested that appropriate action may kindly be taken to implement the decisions of the AICTE and communicate the progress made in this regard to the Southern Regional Committee of the AICTE, Madras under intimation to this office.
